## **CANCELLATION**

If cancellation occurs 60 or more days before departure, there will be no loss of fees. Any cancellation made between 30-59 days will result in application of your fees for a future retreat. Any cancellation between 0-30 days of the retreat departure will result in a total loss of funds. We reserve the right to cancel the retreat if it is not meeting the retreat minimum (if we do so your deposit is refunded). Trip cancellation insurance is strongly recommended if there is a possibility that you might have to cancel your participation in the retreat. All cancellations must be made to Joree Rose in writing and any refund requests must be made in writing to Joree Rose within 30 days of the return date. The Bay Area Mindfulness and Therapy Center, and/or Joree Rose reserves the right to cancel any retreat prior to departure for any reason whatsoever, including an insufficient number of participants or logistical problems (e.g. acts of God, pandemic, war, strikes, etc.), which may impede retreat operations.
